HISTORY AND GEOGRAPHICAL LOCATION OF THE UNIT

Founded in 1994, Langage, Langues et Cultures d'Afrique Noire (LLACAN, UMR 8135) is a joint research unit of the CNRS and the Institut National des Langues et Civilisations Orientales (INaLCO) whose premises are located on the Villejuif Campus at the Centre André-Georges Haudricourt.

SCIENTIFIC DOMAIN

The unit comprises the majority of contemporary French Africanist researchers, and it continues to be the most important entity in this field, with a high international visibility. It is not organized into teams, and instead has chosen a structure around three thematic fields that allow for multiple and dynamic interactions between the researchers: grammatical analysis, comparative linguistics and literatures in African languages. A transversal theme on Corpora and databases provides additional opportunities for exchange. Originally, the geographical focus was restricted to sub-Saharan Africa, but it expanded over the years to include the whole of Africa.

Since its foundation, the unit has been actively engaged in a large number of research initiatives. It is a member of Labex EFL and of the Fédération Typologie et Universaux Linguistiques of the CNRS (FR 2559). It is also a member of the Consortium CORLI (corpus, langues, interactions) as well as of the GIS "Études Africaines". It hosts a number of national (e.g., ANR) and international (e.g., ELDP - Endangered Languages Documentation Programme, ERC – European Research Council) projects, which bring together LLACAN researchers, colleagues from other French research units and international colleagues.

GLOBAL ASSESSMENT OF THE UNIT

LLACAN is a very dynamic unit with an impressive level of scientific productivity. It has an excellent publication record in terms of both quantity and quality, thereby making strong contributions to both general linguistics and specialized African studies. Its activities in the digital humanities are especially commendable, testifying to its capacity for innovation and its commitment to the sustainability of data and the verifiability of analyses. The unit takes an active part in outreach activities, having a policy of dissemination to the larger public both in France and in various African countries. And it is successfully engaged in research training by integrating a large number of PhD students into its projects and providing them with training opportunities, as well as by contributing to capacity building in Africa. The unit is well-organized and structured, conveying an exceptionally strong sense of identity and inner coherence.

LLACAN has articulated an excellent and convincing scientific strategy, building up on its recognized strengths. It is to be commended for continuing its fundamental research of documenting African languages and literatures, analyzing them from functional-typological, historical-comparative and anthropological perspectives, and for contributing to developments in language technology. Since the last report, LLACAN has made a major transition from an organization according to thematic areas to a more flexible organization structured around smaller projects.
